Minutes:

A motion was made by Amundson to approve the minutes for Apr 11th, 2023. Motion was seconded by Hulscher. Motion passed with all members voting aye.

Department Report:

Fire Department – Monte Koopman discussed how they went on to three EMS calls, one EMS Training, and Responded to a fire at Dollar General

Sheriff's Report – Patrolled for 75.63 Hours for the Month of March.

Parks/Recreation – Jerrit Pedersen discussed the new lawnmower will be showing up on April 19th.
